

Terms & Conditions

Agreement with the User

AsteReverse.com is an online shop considered also a rebate auction site. The site grants the opportunity to purchase articles through auctions. The two lowest unique bids win the articles as stated in the Terms and Conditions and by the rules.

General Rules

Every customer will create a USERNAME and that will be the only identification visualized on the site followed by a password. By Login through a Username and password will allow the customer to enter and to manage his/hers account. Every customer is responsible of the maintenance of the privacy of his/her Username and Password and he/she must immediately inform if third parties are being authorized to use such data's. AsteReverse will not be responsible for the non correct use of the Username and Password.

By Accessing the site the customer maintains the right to act individually and to guarantees his/her own authority and ability to approve and to understand the Terms and Conditions, General Rules and Privacy Policy and to declare have reached the age of 18 years in the State of Residence.

The access to the Account is permitted only by the registered customer, and it is not possible to assign or to transfer his/her account to other Users or entities. Each customer is legally authorized to use the service after having completed the registration form and after it has been approved by AsteReverse. In the registration form the customer must insert his/her name, surname, residence address, e-mail address, date of birth and telephone number. If the information provided by the consumer change, he/she has the responsibility to maintain an updated record.

Cancellation Policy

All cancellations must be received in writing no later than one month prior to the registration. Phone cancellations will not be accepted. Cancellations may be received by email or by regular mail. It is up to the registrant to confirm receipt of the cancellation request. Cancellations are free of charge. We are not liable for any expense incurred by Users as a result of their cancellation.

Return Policy

If you are not satisfied with our products, you may return them in resalable condition within 10 (ten) days for a full refund (not including shipping and handling costs). Items may be returned no later than 10 (ten) days from the date shipped. All refunds will be paid based upon the price list of the product specified on the site. Any unauthorized returns will be shipped back at customer's request and expense, including shipping and handling fees. When returning merchandise, it is necessary to include the invoice number. If the merchandise is returned without this information the refund will not processed until the invoice number is received. It is our responsibility to verify the receipt of such information.

Shipping and handling Policy

Shipping and handling costs vary between 6.50 euro to 30.00 euro, depending on the article (such terms do not include vehicles, motorcycles, scooters, etc. which are picked up directly at the pointed out dealerships. Picked up vehicles are free of shipment costs). Shipment costs are paid upon delivery. Delivery is within 7 (seven) working days.

Services

Our services consist in: marketing organization, supplier and article selections, general management, carrying out and finalizing the sales included or shipment of winning articles.

Our services also include the management and updating of the site as web and software, costs of administration of the servers, of employees, of the advertisements related to the company. The customer understands and accepts the "Service policy" from which he/she decides to purchase credits for information services from which he/she will receive a purchase invoice. Registration and access to the Site are free. To use the "Service", the User needs to purchase credits and to deposit them into his/her personal login area. The customer understands and accepts that credits are not reimbursable for any purpose. Associated to particular promotions the company may give out credits bonuses. By purchasing the "Information Service" the customer receives credits that he/she can use for the "Information" in reference to each bid. The quantity of credits for "Information" deducted by a user's account fits every auction of the site. When registering the site, as a customer you understand and accept our payment policy that guarantee the continuity of the "Service", and the "Information" for every single bid.

The winners of an auction will be visualized in the home page immediately after the ending of the auction. Once the software has calculated, checked and verified the result of each auction, it will then be visualized in the expired auctions section of the page. Temporary winning results in the user's personal areas before the auction time is closed are not valid. Only the ending results visualized in the expired auctions section of the page are considered valid.

The customer must activate no more than one account. He/she must provide a correct data's, correct residence and e-mail address and must not furnish false or deceptive information to AsteReverse. If this were to occur AsteReverse maintains the right to suspend any account until further verifications of correct data's are inserted. In case of suspended account the customer must contact us using the email registration address providing all updated information. If the given data's are not approved, AsteReverse maintains the right to cancel any account considered illegitimate and the customer loses the right of reimbursement of any purchased credits still held in the account.

The customer that does not respect the Terms and Conditions, General Rules and Privacy Policy will be immediately expelled by the site and he/she lose the right of reimbursements of purchased credits still held in the account.

The customer verified or suspected of fraud or abuse of the present will be immediately expelled by the site and he/she lose the right of reimbursements of purchased credits still held in the account.

AsteReverse reserves the right to cancel any account that is inactive for the last one year, that has not participated or bided for the last one year, and he/she lose the right of reimbursements of purchased credits still held in the account.

The present agreement remains valid throughout the entire period in which the customer is registered to the site. The customer can end his/hers agreement by eliminating his/hers profile by following the instructions in the personal reserved section of the account. All purchased credits are not reimbursable.

The closing or suspension of the account for an any form of manipulation of the sale (defined by AsteReverse), will determine in case of a winning article the non delivery of the same, and the costumer will be legally prosecuted. If the alteration of the system is discovered after the delivery of the article, the costumer is obligated to return or to pay the commercial value of the item within 10 days from our notice. In case of redelivery or missed of payment the costumer will be legally prosecuted.

AsteReverse.com reserves the right to vary, to modify, to suspend or to interrupt any part of the site at all times, to impose limits or to or access of the site without obligation of responsibility toward third parties.

AsteReverse reserves the right at all times to modify or to interrupt, temporarily or permanently, the Website with or without notice.

The costumer is not authorized to use AsteReverse's logos without a granted permission. When registering the site the costumer accepts to receive e-mails or any form of communications from AsteReverse.
